To the American Senior Adviser for Ministry of Justice

Dear Mr.

I would like to begin my letter by saying that the Faylee Kurds in Iraq were most exposed group of Iraqis to vicious crimes of the fascist Baath – because of the ethnic cleansing campaigns which took the form of massive deportation campaigns over the years in which about 400,000 Faylee Kurds were deported, or be in stripping them of all their rights and citizenship, confiscating all their properties and businesses and donating them to their supporters who up to this day refuse to leave them, trying to make this injustice take over as a *de facto* of new Iraq, a massive deportation process in conjunction with detaining tens of thousands young Faylee Kurdish men, women and children back in 1980-1981 and onwards, all of whom did not come out a live and the where about of their graves and bodies remains a mystery to us up to this moment.

So many Faylee Kurd's mothers are deprived of the fundamental right to touch the soil in which their children are buried, for either they do not know where, or for them still in the Diaspora.

The sufferings of the Faylee Kurd have been a consequence for the Iraqi citizenships law that was issued back in 1924, and by that the Faylee Kurd were considered as of Iranian origin by the Baath – despite been an indigenous inhabitants of this land.

The Faylee Kurds firmly believed in Mr. President George W. Bush's statements on bringing order, justice and democracy into a civil society in Iraq, as we do indeed see it in the relentless effort and measures taken by the civil administration of Mr. Paul Bremer.

Based on the new reality tacking shape in Iraq we are encouraged to come forward with our case and ask you to help us to achieve a long lost justices as a first step of this process we ask you to help our people to return from exile and help us to bring to justices the war criminals who are responsible for the disappearing and mass executions of tens of thousands of our children, whose only crime was being a Faylee Kurd, also put things right in helping us to gain back our properties and businesses, and to evacuate them from those aggressive armed gangs who refuse to leave, many of them bogusly claiming ownerships of our properties.



Your support in helping us will be remembered for generations, since it only leads to peace, justice, and respect of human rights to prevail in Iraq, also to introduce true constitutional democracy. Only under these measures Faylee Kurd in particular and Iraqis in general feel safe and secure again after decades of terror, and lackeys of deposed Saddam lose their battle against the coalition forces and Iraqis.
